More Than 20 Years of Experience

For more than two decades, our goal has remained the same: Deliver meaningful prescription savings without compromising safety.

Founded in 2002, CANARX was the first International Prescription Service Provider (IPSP) to introduce a personal importation plan for the beneficiaries of a self-funded program in America. The CANARX program remains the standard by which all importation programs are measured.

Where Modern International Programs Began

Through strict sourcing standards, a carefully managed formulary and continuous oversight, CANARX has built a program designed to protect both plan sponsors and the members they serve.

All modern importation programs are based on the CANARX principles, but they all miss one critical element: INSURANCE.





UNPARALLELED SAFETY. ONE-OF-A-KIND INSURANCE.

Fully Insured. Fully Protected.

Many international prescription programs promise savings. Only one is fully insured, door-to-door.

CANARX recognizes that plan holders have a fiduciary responsibility to beneficiaries, requiring due diligence to ensure that any international option endorsed or promoted does not put the member at risk. In many cases, international options that claim to be insured are not fully insurable due to their structure, processes, sourcing, or formularies. Not all insurance is equal; the difference lies in the details. Many CANARX competitors do not have insurance for their operations and use pharmacies and doctors without liability coverage that extends to U.S. residents, creating a high-risk scenario for both the plan holder and the beneficiary. CANARX has closed the insurance gaps with the following:

Professional Liability (Errors & Omissions) Insurance:

Professional Liability insurance covers errors, omissions, and negligence in medical billing and administrative services, and extends to privacy-related liability arising from professional services.

Commercial / Medical Malpractice Liability Insurance:

Medical Malpractice insurance provides coverage for professional negligence and bodily injury arising from professional services, including vicarious liability for physicians, pharmacists, and pharmacies.

Cyber Insurance: Cyber insurance addresses data security, privacy incidents, ransomware, cybercrime, system damage.

Directors & Officers (D&O) Liability Insurance:

Protects directors, officers, and the organization against claims arising from governance activities, management decisions, and fiduciary responsibilities. Coverage includes employment practices claims and regulatory investigations.

Safety by Design

This one-of-a-kind insurance is only possible via the strict safety standards by which CANARX operates. These standards were drafted in the early 2000's, working alongside state boards of pharmacy to create the safest, most effective personal importation program in the world. The CANARX Gold Standard remains the most respected, trusted and reliable solution in the industry.

True Tier 1 Pedigree

CANARX only works with licensed and regulated pharmacies in one of three Tier 1 Countries – Canada, Australia and the United Kingdom. All members are contacted prior to each order to inform them which pharmacy they should expect the order from. The CANARX team regularly visits each pharmacy partner to review licensing, insurance, and adherence to safety standards.

CANARX does not engage in transshipping, drop shipping, free trade zones, or work with any unregulated or unlicensed pharmacies.

The pharmacy arranged by CANARX to serve an member will deliver the brand-name medicine prescribed by the member's physician; it will not ship generics or compounded medicines or make any other substitutions.

Protection Matters

- ▶ Medications requiring ongoing physician monitoring

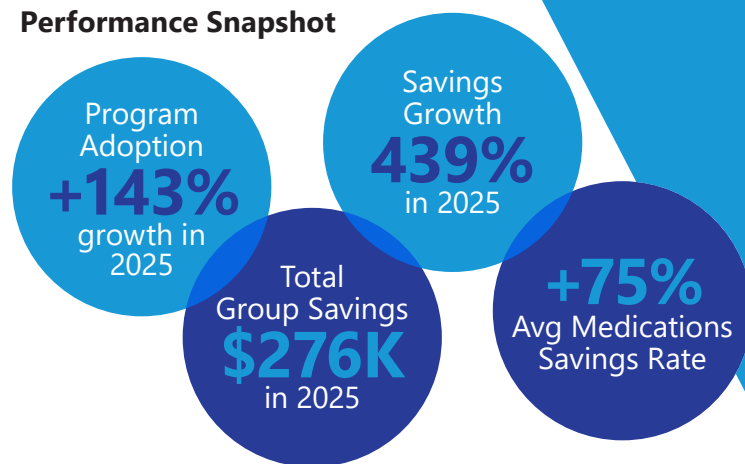

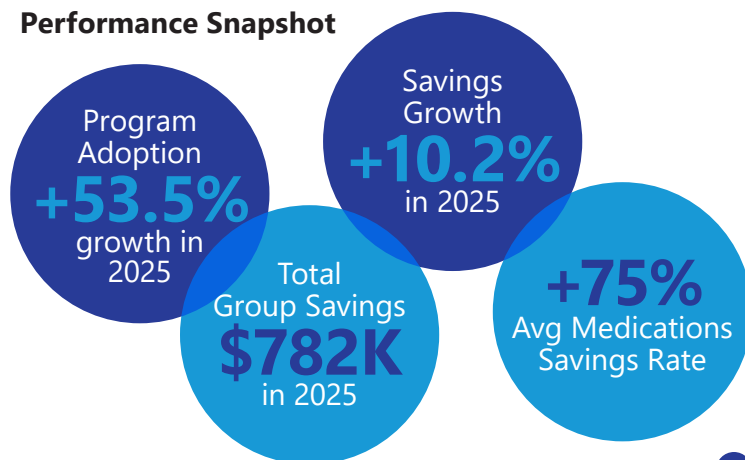
